Institutes include the units established under the following provisions and those engaged in training, research and extension activities:

- a. Societies registered under Societies Registration Act/ Co-operative Societies Act, 1959,
- b. Public Trust and Private Trust performing public functions,
- c. Non-Profit Companies registered under Section 25 of the companies Act, 1956,
- d. Industrial houses including Multi-National Companies (MNCs),
- e. Statutory organizations (like Banking, Federations etc.),
- f. International organizations (like Banking, Federations etc.),
- g. Professional bodies and
- h. Central & State Government Institutions.

Application format may be downloaded from the University Website www.bcu.ac.in and dully filled in application forms along with enclosures are to be submitted to the University in 8 SETS with DD as prescribed by the university, the detailed fee notification is notified in the university website and also enclosed with their notification in favour of "Finance Officer, Bengaluru City University, Bengaluru" (DD to be submitted to the Finance Branch of BCU) per subject of study for seeking fresh recognition.

The Institutions managed by the State Government or Central Government are exempted from payment of fee. There will be 50% concession in the recognition fee for the Institutions managed by SC/ST Managements.

Important Notes:

- i. Incomplete applications (including part-payment) will be rejected. Expert Committee will not visit such Institutions/Centers.
- ii. The Head of the Institutions/ Centers must ensure that full payment of recognition fee through DD shall be paid at the time of submission of applications to the University.
- iii. Once the application is rejected, it will not be considered again.

NOTE: The Examination Fee Structure is 5 times (i.e. regular program examination fee fixed by the Bengaluru City University) for those courses and institutions which are offering the program in collaboration with the Bengaluru City University by signing M.O.U.
